



## Communicable Disease Plan (CDP) for Camp and Bowl Games

The health and welfare of our campers, staff and family attending our venues is at the forefront of all our decision making to ensure an enriching camp experience.

1. **Parameters for entering camp:** Social distancing and health screening in accordance with the CDC, local and national guidance will be practiced at every station of the in-check process.
2. **Camp health screening process:** ATC staff will be conducting health screening upon arrival. All campers will have temperature checks conducted upon entering the camp and continue routinely throughout the camp week. A log entry of any camper that displays a temperature reading above 100.4 will be recorded and monitored for further changes and referral for care as needed.
  - a) With a high reading a series of questions as listed below will be administered:
    - i. Have you been in contact with anyone diagnosed with Covid-19?
    - ii. Have you had a fever in the last 48 hours?
    - iii. Do you currently have a cough, sore throat or respiratory problem?
  - b) Should the answer be YES to any question or the individual exhibit respiratory symptoms including cough or shortness of breath they will be reported to local medical staff for care and treatment.
3. **Camp's control measures:** Common surfaces to include tables, chairs, door knobs, light switches, tents, sink handles, latches and training equipment will be sanitized prior to and throughout the camp to minimize any transmissions of infectious diseases.
  - a) We'll no longer have a communal hydration station, cups will be filled by ATC staff and delivered to campers in small groups while maintaining social distancing. When available at any given location we will serve single use prepackaged containers that will be distributed to attendees instead of cups and disposed of properly to prevent cross contamination.
  - b) Campers will not be allowed to bring their own ball or any other shareable equipment to the camp.
  - c) Parents attending the practice sessions will be required to abide by the CDC guidelines for social distancing and limit interactions with attending campers throughout the sessions.
  - d) With the assistance of our host facility staff we'll maintain a watchful eye on facility janitorial services to ensure restrooms and dining facilities are maintained to the CDC's established guidelines.
  - e) Residence Hall Restrict Access. We will be restricting families' access to the residence hall facility. Specifically, access must be limited to the front door of the facility or the door of the child's classroom when entry is to the outside area. Room check-in and set-up assistance beyond these points will be provided by staff only.
  - f) We'll do everything humanly possible to make sure we're following established "best practices" put into place at each location to alleviate fears of our O-D family members.
4. **Staff training:** The coaches and administrative staff will receive guidance and training in dealing with

communicable diseases detection and management and will be made aware of all plans put into effect for a safe camp operation.

- a) Staff will be required to have their temperature readings conducted and routinely monitored for health-related issues prior to, throughout and following each camp. Any issues identified will be documented for record to ensure removal from the camp circuit and reported to local health authorities for treatment.
  - b) The staff will serve as an extension to the ATC medical team to ensure real-time surveillance for the quick screening assessment of attending campers with recommendations for review or treatment.
5. **Access to resources:** To provide support the following resources are made available to assist the onsite staff and all camp personnel dealing with the care of individuals involved with the O-D program:
- a) The positioning of hand sanitizer dispensers at key entry or exit points will be set-up to allow ease of use for all personnel to prevent the spread of diseases through hand contact.
  - b) Mask or face covering will be recommended for use by camper in situations where social distancing can not be maintained (non-mandatory ware).
  - c) Non-contact Infrared Thermometers will be kept by the ATC medical staff and key staff personnel to perform routine checks as campers enter and exit facilities or prepare to take the field of play for each practice session.

6. **Daily Commuting** – Check-In modifications to sign-in/sign-out procedures will be as follows:
- a) All sign ins will be done by our staff at the point of roll through drop-off.
  - b) Sign outs will be done by the guardians.
    - i. Camper will be staged with social distancing in mind and call up to the check-out station as their guardian arrives for pick-up.
    - ii. Person picking up the camper will be asked to provide their own pen if at all possible, as the pens used in our facility have to be disinfected after each use. This makes check out faster and easier for both parties.
7. **Restrictive eating guidelines:** We'll follow the established social distancing guidelines of the host facility instead of our normal communal settings.
- a) Campers will be released in smaller groups to allow for a transitional flow of personnel through the dining facility and permit the serving staff time to conduct proper cleaning between each group arrival.
8. **Response Protocols:** With the virus having been spreading widely, we will always assume that someone infected will at some point come to our site. Our plan describe how the staff will react.
- a) Based on CDC guidance to practice social distancing the goal now is to limit direct personal exposure within six feet.
    - i. The first step is to separate the suspected infected individual from the campers and staff.

- ii. Our goal is to limit the possible spread by educating, training and frequently reminding everyone about good hygiene. Have everyone wash their hand, sanitize themselves and limit contact prevent unnecessary contact with others.
  - iii. Stop all movement and camp activities until the situation for exposure is under control and the camp site decontamination has been completed.
- b) Should a staff member test positive or is positively exposed, they will be asked to stay home and self-isolate for at least 14 days. They will be required to stay in touch to monitor progress for any further measures.
  - c) Make contact with the local emergency department for onsite immediate care and guidance for communicating with the DEHEC and or CDC office if need be beyond the emergency contacts.
  - d) All measures taken to comply with the response plan will be reported to the Offense-Defense home office in uni-sent
9. **Additional Rules:** Cash transactions will be kept to a minimum, so we request that tuition for camp be prepaid prior to onsite check-in.
- a) Also we ask that parent utilize the O-D Card account for camper store sales transactions to allow for contactless payment.
  - b) Credit card will still be excepted onsite, however the card swipe or card insert system will be utilize to limit the physical contact with customers and handling of their cards. These systems will be sanitized after each customer use.
10. A key part of our plan is communication and education. We're sure to communicate sensitively and honestly with you our campers and family about new developments, our plans and your needs (while respecting individual privacy). We're on top of things here and hopefully everyone feel safer, look forward to seeing each one of you out on the camp circuit this season.
